2           **CHAIRMAN BROWN:**   Moving on to Item 9.

3           **MS. BRUCE:**    Good morning, Commissioners.

4           **CHAIRMAN BROWN:**   Good morning, Ms. Bruce.

5           **MS. BRUCE:**    I am Sonica Bruce on behalf of  
6 Commission staff.

7                   Item No. 9 addresses Crooked Lake's request to  
8 extend the time to complete the Phase II pro forma plant  
9 items and the renewal of its insurance.

10                   On March 31st, 2016, the utility requested  
11 that it be granted an extension of approximately  
12 three months to complete the Phase II pro forma plant  
13 items. The utility was granted 12 months to complete  
14 the pro forma plant items, which should have been  
15 completed on April 20th, 2016. In addition, as a  
16 condition of the implementation of the Phase II rates,  
17 the utility is required to maintain the general  
18 liability insurance.

19                   Staff recommends that the extension be  
20 granted. This extension does not place any burden on  
21 the customers. Phase II rates cannot be implemented  
22 until all costs for the pro forma are evaluated.

23                   The utility is not present, and there has been  
24 no customer contact. Staff is prepared to answer any  
25 questions that you may have.

1           **CHAIRMAN BROWN:** Thank you so much. I don't  
2 see any issues with this.

3           Commissioners, do you have any questions?

4           **COMMISSIONER GRAHAM:** Move staff.

5           **CHAIRMAN BROWN:** Is there a second?

6           All those in favor, say aye.

7           (Affirmative vote.)

8           The motion passes on all issues on Item 9.

9           And I do want to say, before we get to Item  
10 10, we have a staff -- an attorney here that is back  
11 after some issues that he has had personally, and we are  
12 so grateful. We've missed him very sorely. Keino Young  
13 is here, and we're just so happy to have you back here.  
14 This is his first agenda. And, Keino, welcome. We've  
15 missed you. Thank you.
