ERRATA NOTICE

On May 13, 2016, South Florida Hospital and Healthcare Association (“SFHHA”), by and through its undersigned attorneys, filed notice that it served its Eighth Set of Interrogatories (Nos. 165-196) and its Ninth Set of Document Requests (Nos. 174-205) (“Discovery Requests”). SFHHA has identified five minor errors with respect to the Discovery Requests filed. First, Interrogatory No. 173 incorrectly references Interrogatory No. 170, and should instead reference Interrogatory No. 172. Second, Document Request No. 182 should reference Interrogatory No. 172, and not Interrogatory No. 170. Third, Interrogatory No. 176 contains an inadvertent “(A)” at the beginning of the request, which should be removed to avoid any confusion. Fourth, Document Request No. 192 incorrectly references Interrogatory No. 181, and should instead reference Interrogatory No. 195. Lastly, the first pages of the Certificate of Service for the Discovery Requests incorrectly reference Interrogatory Nos. “(165-194)” and Document Request Nos. “(174-206)” respectively, but should instead reference Interrogatory Nos. “(165-196)” and Document Request Nos. “(174-205)” respectively. To rectify these minor errors, and avoid confusion, SFHHA has served this errata notice, along with clean and red-line versions of the above-referenced Discovery Requests, concurrent with this notice, to replace the original submitted on May 13, 2016.
