**PETITION OF JEA
FOR LEAVE TO INTERVENE**

Pursuant to Chapter 120, Florida Statutes and Rules 25-22.0376 and 28-106.205, Florida Administrative Code, JEA hereby files this Petition for Leave to Intervene in the above captioned docket and in support thereof states as follows:

1. JEA is a public agency existing under the laws of the State of Florida. JEA is authorized by the laws of the State of Florida to, and does, provide retail natural gas service to industrial and commercial end users within the greater, Jacksonville, Florida area.

2. JEA is a recognized third party supplier ("Pool Manager") on the Peoples Gas System ("PGS"), serving a number of consumers in the greater Jacksonville, Florida area that elected to take service under the PGS Natural Choice Transportation Service ("NCTS") tariff.

3. The modifications to the NCTS tariff that PGS has proposed will greatly impact the costs incurred for JEA to provide service to its natural gas customers in the greater Jacksonville, Florida area,
to wit:

a) change "...the rate, or reservation charge, at which releases of upstream capacity to Pool Managers under Rider NCTS will be made"

b) modify the "cash-out" price for negative monthly imbalance amounts.

3. JEA's substantial interests are subject to determination in and will be affected by the Commission's decision in this docket. JEA's rights and interests cannot be adequately represented by any other party in this docket. JEA's participation in this matter will not unduly delay these proceedings or prejudice any other party. Accordingly, JEA is entitled to intervene in this docket.

4. JEA respectfully requests that it be granted leave to intervene and participate fully as a party in this proceeding in order to protect its interests.


