Re: Protecting customers from imprudent costs as TECO fails to study coal phase-out as an environmental compliance option

Dear Commissioners:

The Florida Chapter of Physicians for Social Responsibility has informed Sierra Club that they would join in undersigning the comments submitted June 3, 2016, signed by Sierra Club and supporting parties.

PSRFL advised that Dr. Jacobson at Stanford University has projected that the State of Florida will avoid health costs of \$40.8 billion per year and avoid 2,681 air pollution-related deaths per year by transitioning to 100% wind, solar, water energy by 2050. See, <http://thesolutionproject.org>. Additionally, under the Clean Power Plan, the economic benefits to public health and climate would range between \$55 billion and \$93 billion in 2030; 2,700 to 6,600 premature deaths and 140,000 to 15,000 asthma attacks in children would also be avoided, according to the EPA.

We join Sierra Club in asserting that health impacts should be top of mind for state regulators and utilities.
