SECTION 63.71 APPLICATION OF AT&T

AT&T Services, Inc. on behalf of its affiliates, BellSouth Telecommunications, LLC, Illinois Bell Telephone Company, Indiana Bell Telephone Company, Inc., Michigan Bell Telephone Company, The Ohio Bell Telephone Company, Pacific Bell Telephone Company, Southwestern Bell Telephone Company and Wisconsin Bell, Inc., collectively referenced herein as AT&T, applies for authority under Section 214(a) of the Communications Act, as amended ("the Act"), 47 U.S.C. § 214 and Section 63.71 of the Federal Communications Commission's ("Commission") rules, 47 C.F.R. § 63.71, to discontinue offering Operator Transfer Service ("OTS") in Alabama, Arkansas, California, Florida, Georgia, Illinois, Indiana, Kansas, Kentucky, North Carolina, Louisiana, Michigan, Mississippi, Missouri, Ohio, Oklahoma, South Carolina, Tennessee, Texas and Wisconsin. As required by Section 63.71(a) and (b) of the Commission's rules, AT&T is

providing the following information:

Name and Address of Carrier (47 C.F.R. §§ 63.71(a)(1), (b)(2)):

Date of Planned Service Discontinuance (47 C.F.R. §§ 63.71(a)(2), (b)(2)):

AT&T plans to discontinue the service on or after September 30, 2016, subject to Commission authorization of the discontinuance pursuant to 47 C.F.R. § 63.71(c).

Points of Geographic Areas of Service Affected (47 C.F.R. §§ 63.71(a)(3), b(2)):

AT&T will discontinue this service throughout its geographic service areas in Alabama, Arkansas, California, Florida, Georgia, Illinois, Indiana, Kansas, Kentucky, North Carolina, Louisiana, Michigan, Mississippi, Missouri, Ohio, Oklahoma, South Carolina, Tennessee, Texas and Wisconsin.

Brief Description of Type of Service Affected (47 C.F.R. §§ 63.71(a)(3), b(2)):

AT&T's OTS provides for routing of calls requiring operator assistance to a participating interexchange carrier (IXC) as requested by a calling end user. OTS allows an AT&T local operator to transfer a caller who dials zero and wishes to place an interLATA call to a participating IXC. To subscribe to OTS, the IXC must order, install and maintain OTS trunks in every Local Access and Transport Area (LATA) to receive OTS calls from AT&T.

The public convenience and necessity will not be impaired by this service discontinuance because OTS calls have been declining at a rate of about 33.4% per year for the last several years. On average, AT&T has experienced more than a 55.5 % decline in the volumes of these services over the last two years. Equal Access and toll presubscription continues to be available and customers can reach their preferred primary IXC operator by dialing 00, or can reach a different IXC using widely available dial around services such as 10-10-XXX, 8YY numbers, etc. Additionally, customers are taking advantage of more modern technologies and/or services to communicate such as text messaging, instant messaging, social media, mobile calling, voicemail and email.

Brief Description of the Dates and Methods of Notice to All Affected Customers (47 C.F.R. § 63.71(b)(3)):

AT&T mailed its customer notification letters on July 1, 2016, via First Class U.S. Mail.

Copies of this Application are being sent first class U.S. Mail to the public utilities commissions and governors of the affected states and also to the Special Assistant for Telecommunications to the Secretary of Defense, as required by 63.71(a) of the Commission's rules.

Regulatory Classification of Carrier (47 C.F.R. § 63.71(b)(4)):

AT&T is considered dominant with respect to the services to be discontinued.
