Hi Sevini,

We currently have six separate accepted ED Rider applications (one EDR-1 applicant and five ED-1 applicants).

The single EDR-1 applicant expects to meet the minimum threshold for service by September 2016. This customer is in the process of ramping up their new operation and requested that we begin their discount in September 2016.

The five ED-1 applicants consist of four customers that are ramping up their new operations (installing equipment, increasing their product output and/or adding more shifts/increasing their hours of operation). These customers are

recent announcements and are all in their new facility but have not yet met the minimum ED-1 kW demand and/or load factor thresholds. The fifth ED-1 applicant has yet to construct their building. Our best estimate for when they might begin receiving the ED-1 discount is September 2017, but this may change depending on their construction progress.

In DEF's response to Question 1 to Staff's First Data Request, the company states that the six enrolled customers under the ED-1 and EDR-1 riders are not yet ready to commence their respective discounts. The response to Question 2 states that the company expects two customers to commence billing within the next two months. Please explain the status of the other four customers who are not ready to commence billing yet and explain under what circumstances customers would be taking service already, but are not ready to commence billing under the riders?
