SUBJECT: NOTIFICATION OF THE AVAILABILITY OF THE COMBINED LICENSE

APPLICATION FOR TURKEY POINT UNITS 6 AND 7 IN ACCORDANCE WITH

TITLE 10 OF THE CODE OF FEDERAL REGULATIONS (10 CFR) 50.43

REQUIREMENTS

Dear Ms. Stauffer:

On June 30, 2009, Florida Power and Light (FPL) tendered a combined license (COL) application for two AP1000 advanced passive pressurized water reactors to be located at the Turkey Point site in Miami-Dade County, Florida. The reactors are to be identified as Turkey Point Units 6 and 7. The application is currently under review by the U.S. Regulatory Commission (NRC) staff.

In the June 30, 2009, letter that transmitted the application, FPL stated that it was submitting the COL application pursuant to the requirements of Title 10 of the *Code of Federal Regulations* (10 CFR) Part 52, "Licenses. Certifications, and Approvals for Nuclear Power Plants," and requesting the associated materials licenses under 10 CFR Parts 30, 40, and 70. In addition, FPL stated that the COL application incorporates by reference Appendix D to 10 CFR Part 52, as amended by Westinghouse Electric Company's (Westinghouse) Design Control Document (DCD) Revision 16 (submitted May 26, 2007), and updated by DCD Revision 17 (submitted September 22, 2008). Since the initial submission of the COL application, FPL has updated it to reference Revision 19 of the AP1000 DCD, which was incorporated by reference into 10 CFR Part 52, Appendix D, "Design Certification Rule for the AP1000 Design," effective December 30, 2011.

In accordance with the requirements found in 10 CFR 50.43(a)(1), the NRC staff is providing this written notification to you because the staff has determined that your agency has jurisdiction over the rates and services that are incident to the construction and operation of Turkey Point Units 6 and 7, as proposed by FPL.
