On September 14, 2016, Ni Florida, LLC (Ni or Utility) filed its request for confidential classification for Document No. 07527-16. The document is part of Ni's response to Staff's Third Data Request, Question No. 2, dated September 14, 2016. Certain information produced in response to Staff's Third Data Request consists of parent company employee names, titles, and total compensation. The Utility claims the information is intended to be, and is treated by, Ni as private and confidential, has not been disclosed externally, and has been strictly controlled internally. Staff has reviewed the documents and concurs with the Utility that the nature of the information meets the requirements set forth in Section 367.156, Florida Statutes, whereby disclosure of the information would harm Ni's competitive business interests and would impair the ability of the Utility to contract for employees on favorable terms. Therefore, staff recommends that Ni's request for confidential classification of Document No. 07527-16 be approved.
