STAFF RECOMMENDATION (Motion Ready): Approve Agenda Item (ID # 8099) amending the City of Ocala Utility Services tariff schedule sheets No. 12.1 and 12.2 to include additional private area lighting options with associated fees

OCALA'S RELEVANT STRATEGIC GOALS: Fiscally Sustainable

PROOF OF PUBLICATION:

BACKGROUND:

Private area lighting is available to our customers allowing for different lighting fixture options. The Trilogy development will be installing lighting and has requested fixtures that we do not currently stock. We have determined that it is cost effective to stock the fixtures and to offer them to other customers that desire similar installations. The customer will pay the full initial cost of the labor and materials to install these fixtures. They will also pay a monthly fee that covers the energy and maintenance cost of the lights.

FINDINGS AND CONCLUSIONS:

The rate tariff book needs to be amended to reflect the monthly charges for Ocala Electric to supply and maintain the fixtures selected by Trilogy. The fee will cover the cost of maintenance and energy. Staff recommends approval of the amended rate tariff sheets no. 12.1 and 12.2 to be effective June 2, 2015.

FISCAL IMPACT:

Customer will pay the initial installation cost to install the lights and monthly fees to cover the energy and maintenance of the fixtures.
