Information provided to the City of Cape Coral via letter dated March 26, 2015 from Lee County Electric Cooperative, Inc. ("LCEC") Director of Regulatory and Governmental Relations and CRCO, Mr. Frank Cain, informed the City as follows: "LCEC rates are reviewed for any improper subsidization by the Florida Public Service Commission."

The City of Cape Coral is aware that in the past the Commission has investigated the rate structure and improper subsidization of rates by other rural electric cooperatives, for instance, Talquin Electric Cooperative, Inc. and Choctawhatchee Electric Cooperative, Inc., as well as the City of Wauchula and Gainesville Regional Utilities. The City is sure that other such investigations likely have occurred. However, the City cannot locate any documents or identify any proceeding wherein the Commission has reviewed LCEC's rate structure for improper subsidization. By this letter, the City of Cape Coral requests that the Commission provide the City copies of any documents relating to any past Commission investigation of improper subsidization in the LCEC rate structure.

The City further requests that if the Commission does not have any such records that the City be so informed.
