Request for Confidential Classification for Document No. 09131-16

On December 5, 2016, Florida City Gas (FCG), d/b/a City Gas Company of Florida filed a request for confidential classification for Document No. 09131-16. This document contains a confidential cost of service summary and a confidential revenue analysis comparison prepared to facilitate FCG's presentation to the Commission at the December 6, 2016 agenda conference. The information in the document for which FCG seeks confidential treatment was derived from information in Document No. 08582-16 for which Commission staff recommended approval of FCG's request for confidential treatment on November 3, 2016. The document contains customer-specific information regarding rates, terms, and forecasted gas transportation volumes and revenues which could be used by others to gain unfair competitive advantage in the market. Staff has reviewed the document and concurs with FCG that the nature of the information meets the requirements set forth in Sections 366.093(3)(d) and (e), Florida Statutes (F.S.), whereby the disclosure of the information would harm the competitive business operations of FCG.

Therefore, staff recommends that the request by FCG for confidential classification of Document No. 09131-16 be approved. Staff notes that the petitioner also stated that Section 366.093(3)(a), F.S., would apply to the information; however, staff did not evaluate the applicability of this statutory provision since the nature of the information meets the requirements set forth in Sections 366.093(3)(d) and (e), F.S.
