Attached please find petitions with signatures from Don Pedro and Knight Islands opposing the recent request for a rate increase by Bocilla Utilities, Inc. [PSC Docket # 160065]. Please note that at this time of year it is impossible to contact all the residents (home owners) of the islands as they are not present for various reasons. Many of the residents treat their island homes as rental units, others have second homes elsewhere, and several are from foreign countries.

We believe that over 130 signatures represents the sentiment of the majority of property owners on Don Pedro and Knight Islands (the geographic water utility service area of Bocilla Utilities, Inc.). Those that did not add comments expressed their opposition verbally to the Palm Island Estates Association, Inc. Board members as the signatures were collected.
