
Dear Ms. Stauffer:

OF TERRITORIAL AGREEMENT BETWEEN TAMPA ELECTRIC
COMPANY AND WITHLACOOCHEE RIVER ELECTRIC COOPERATIVE, INC.**


Pursuant to Article IV, Section 4.1 of the Territorial Agreement between Withlacoochee River Electric Cooperative ("WREC") and Tampa Electric Company ("Tampa Electric"), as approved in Order No. 23905 issued in Docket No. 900752-EU on December 26, 1990, this filing will serve as Tampa Electric's report on the status of such agreement.

This is to advise the Commission that the subject territorial agreement remains in full force and effect and that the parties have encountered no disputes concerning the provisions of such agreement.

The parties have proposed for Commission approval a slight modification to their territorial agreement to accommodate the provision of electric service to a proposed new subdivision. The parties will advise the Commission to the extent that any other changes are proposed and will petition the Commission to resolve any disputes which may arise concerning the provisions of the agreement which the parties are unable to resolve.
