GENERAL SUBJECT MATTER TO BE CONSIDERED: Docket Nos. 140029-TP – Request for submission of proposals for relay service, beginning in June 2015, for the deaf, hard of hearing, deaf/blind, or speech impaired, and other implementation matters in compliance with the Florida Telecommunications Access System Act of 1991; and 170039-TP - Request for submission of proposals for relay service, beginning in March 2018, for the deaf, hard of hearing, deaf/blind, or speech impaired, and other implementation matters in compliance with the Florida Telecommunications Access System Act of 1991. This is a meeting of the Telecommunications Access System Act Advisory Committee established pursuant to §427.705, F.S. The purpose of the meeting is to discuss current relevant issues related to relay such as Federal and State Regulatory updates, FTRI's Annual Budget, the request for proposals for relay service, a current report on relay service, and other Telecommunications Relay Service updates. 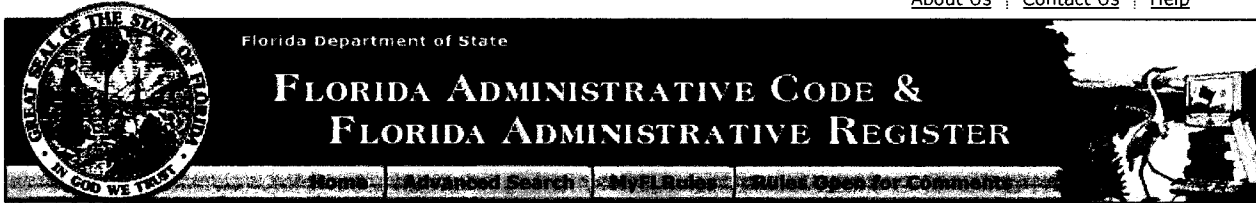
