
To Whom It May Concern:

## CETC Data Request

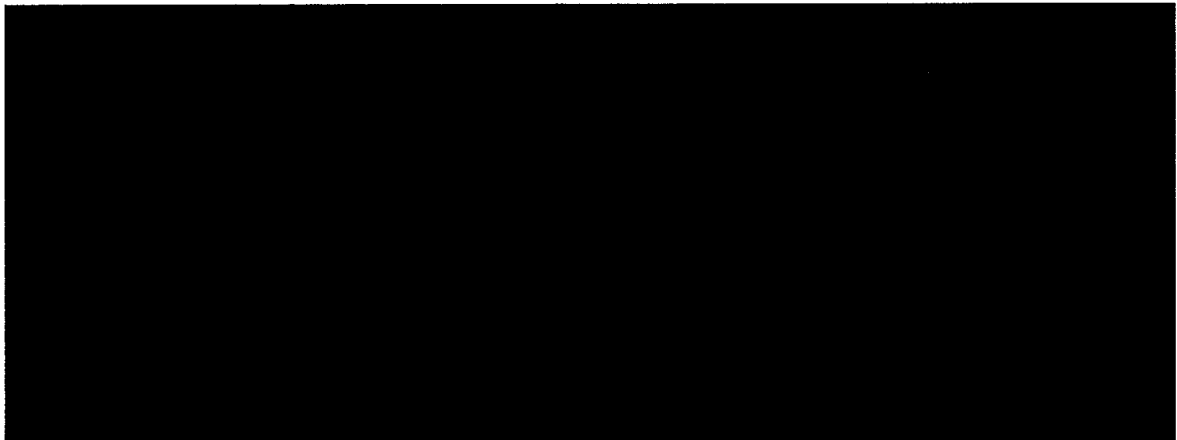
