Dear Ms. Stauffer,

North American Telecommunications Corporation (NATC) and Broadsmart Florida, Inc. (Broadsmart and, with NATC, the Parties) respectfully submit this letter, pursuant to Section 364.33 F.S., to notify the Florida Public Service Commission (Commission) that the Parties have implemented an intracompany reorganization including the transfer of NATC's Florida telecommunications certificate and associated regulated operations to Broadsmart.

### The Parties

NATC is a Florida corporation with principle offices at 305 S. Andrews Avenue, 9<sup>th</sup> Floor, Fort Lauderdale, FL 33301. NATC was granted authority by the Commission to provide Alternative Local Exchange (ALEC) services pursuant to Order No. PSC-01-1450-PAA-TX on August 3, 2001. NATC provided local exchange, interexchange and associated unregulated services to residential and small business customers throughout Florida.

Broadsmart is a Florida corporation also located at 305 S. Andrews Avenue, 9<sup>th</sup> Floor, Fort Lauderdale, FL 33301. A copy of Broadsmart's formation paperwork is provided as **Attachment 1**. Broadsmart is a commonly-owned affiliate of NATC. Prior to the transaction described herein, Broadsmart has not held telecommunications authority or provided regulated services.

<sup>&</sup>lt;sup>1</sup> NATC was originally granted authority under the name Bluewater Communications Corporation. The Commission approved the Company's change of name in Docket No. 011202-TP on Oct. 5, 2001. NATC also was granted authority to provide intrastate interexchange services in Florida; however, these services are no longer regulated by the Commission.

### Description of Transaction

On May 5, 2016, as part of an internal reorganization, NATC transferred its Florida ALEC certificate as well as its regulated operations, consisting of regulated assets and customers, to its commonly-held affiliate, Broadsmart. Post-close, Broadsmart now operates as the authorized service provider for intrastate Florida telecommunications services and is responsible for compliance with all Florida and FCC compliance obligations.

Advance notice of the change in provider was sent to NATC's Florida customers in compliance with the Federal Communications Commission's rules. 47 C.F.R. § 64.1120(e).<sup>2</sup> Consequently, the requirements of chapter 25-4.118 F.A.C. have been satisfied. These customers will continue to receive the same services under the same terms and conditions as they did prior to the reorganization. Moreover, Broadsmart's operations will be managed by the same team of seasoned industry professionals that has guided NATC's operations in the past. Consequently, there is no adverse effect upon customers as a result of the transaction.
