Duke Energy Florida, LLC (“DEF” or the “Company”) pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code (F.A.C.), submits this Notice of Intent to Request Confidential Classification concerning information or documents provided in response to Florida Industrial Power User Group’s (“FIPUG”) First Set of Interrogatories (Nos. 1-27) and FIPUG’s First Request for Production of Documents (Nos. 1-8), filed July 24, 2017. The confidential documents have been filed with the clerk and the redacted versions will be filed as part of DEF’s forthcoming Request for Confidential Classification. Specifically, questions 5 and 6 of DEF’s Response to FIPUG’s First Set of Interrogatories and questions 1 and 3 of DEF’s Response to FIPUG’s First Request for Production of Documents contain information that is proprietary confidential business information. The disclosure of this confidential information would impair the Company’s ability to negotiate on favorable terms and adversely impact the Company’s competitive business interests.
