This letter is in response to your August 16, 2017 customer contact with the Florida Public Service Commission (Commission). Your customer contact requests reconsideration of Proposed Agency Action Order No. PSC-2017-0292-PAA-TP. Rule 25-22.029, Florida Administrative Code (F.A.C.), does not allow for a motion for reconsideration of a proposed agency action order. 
