NOTICE is hereby given that the Florida Public Service Commission will hold a public hearing in the above referenced dockets at the following time and place:

October 26-27, 2017 have also been reserved for continuation of the hearing if needed. The starting time of the next day's session will be announced at the conclusion of the prior day. The hearing may be adjourned early if all testimony is concluded.

PURPOSE AND PROCEDURE:

The purpose of this hearing shall be to receive testimony and exhibits relative to issues and subjects, including but not limited to, the following:

1. Determination of the Projected Levelized Fuel Adjustment Factors for all investor-owned electric utilities for the period January 2018 through December 2018;
2. Determination of the Estimated Fuel Adjustment True-Up Amounts for all investor-owned electric utilities for the period January 2017 through December 2017;
3. Determination of the Final Fuel Adjustment True-Up Amounts for all investor-owned electric utilities for the period January 2016 through December 2016, which are to be based on actual data for that period;
4. Determination of Generating Performance Incentive Factor Targets and Ranges for the period January 2018 through December 2018;
5. Determination of Generating Performance Incentive Factor Rewards and Penalties for the period January 2016 through December 2016;
6. Determination of the Projected Capacity Cost Recovery Factors for the period January 2018 through December 2018, including nuclear costs;
7. Determination of the Estimated Capacity Cost Recovery True-Up Amounts for the period January 2017 through December 2017, including nuclear costs;

8. Determination of the Final Capacity Cost Recovery True-Up Amounts for the period January 2016 through December 2016, which are to be based on actual data for that period, including nuclear costs;
9. Determination of the Projected Conservation Cost Recovery Factors for certain investor-owned electric and gas utilities for the period January 2018 through December 2018;
10. Determination of Conservation Actual/Estimated Amounts for certain investor-owned electric and gas utilities for the period January 2017 through December 2017;
11. Determination of the Final Conservation True-Up Amounts for the period January 2016 through December 2016 for certain investor-owned electric and gas utilities, which are to be based on actual data for that period;
12. Determination of the Purchased Gas Adjustment Cost Recovery Factors for the period January 2018 through December 2018;
13. Determination of Actual/Estimated Purchased Gas True-Up Amounts for the period January 2017 through December 2017;
14. Determination of the Final Purchased Gas True-Up Amounts for the period January 2016 through December 2016;
15. Determination of the Projected Environmental Cost Recovery Factors for the period January 2018 through December 2018;
16. Determination of the Estimated Actual Environmental Cost Recovery True-Up Amounts for the period January 2017 through December 2017; and
17. Determination of the Final Environmental Cost Recovery True-Up Amounts for the period January 2016 through December 2016, which are to be based on actual data for that period.

All witnesses shall be subject to cross-examination at the conclusion of their testimony. The proceedings will be governed by the provisions of Chapter 120, Florida Statutes (F.S.), and Chapter 28-106, Florida Administrative Code (F.A.C.), and 25-22, F.A.C.

The purpose of the prehearing is to consider (1) the simplification of the issues; (2) the identification of the positions of the parties on the issues; (3) the possibility of obtaining admissions of fact and of documents which avoid unnecessary proof; (4) the identification of the exhibits; (5) the establishment of an order of witnesses; and (6) such other matters as may aid in the disposition of the action.

JURISDICTION

Florida Public Service Commission's jurisdiction over the rates and charges of investor-owned utilities is established by the provisions of Sections 366.04, 366.05, 366.06, and 366.07, F.S. Jurisdiction to consider recovery of environmental costs is established by the provisions in Section 366.8255, F.S. Jurisdiction to include costs associated with nuclear power plants through the capacity clause is established by Section 366.93, F.S.

EMERGENCY CANCELLATION OF PROCEEDINGS

If settlement of the case or named storm or other disaster requires cancellation of the proceedings, Commission staff will attempt to give timely direct notice to the parties.
