Georgia-Pacific Consumer Operations LLC (“Georgia-Pacific”) submits this Notice of Cancellation in FERC Docket No. QF93-135-000 on behalf of Palatka, a qualifying facility located in Putnam County, Florida.

Georgia-Pacific Corporation filed an application on Palatka’s behalf for certification as a qualifying cogeneration facility in Docket No. QF90-183-000 in 1990. A second application, certifying the qualifying facility at Palatka as a small power producer, was filed in Docket No. QF93-135-000.

In order to avoid confusion about Palatka’s status, Georgia-Pacific is filing a Notice of Cancellation in FERC Docket No. QF93-135-000. Concurrently, Georgia-Pacific is filing this Notice of Cancellation in FERC Docket No. QF90-183-000 for informational purposes only.
