TO PROPERTY OWNERS REQUESTING SERVICE FROM UTILITIES, INC. OF FLORIDA November 2, 2017

On August 3, 2017, the Florida Public Service Commission approved several changes in Utilities, Inc. of Florida's service availability charges for new connections to the water and wastewater systems. The approved charges are effective for connections made on or after September 5, 2017. If you have any questions about these charges, please contact the utility at (866) 842-8432.

Connection and Meter Installation Charges

The connection charge for water and wastewater service will be the actual cost of installing a connection from the utility's water or wastewater line to the customer's meter or property line. A uniform meter installation charge of \$208 will be charged for 5/8" x 3/4" meters; all other meter sizes will be installed at actual cost.

Main Extension and Plant Capacity Charges

The existing main extension and plant capacity charges for the water and wastewater systems shown below will remain unchanged. For other water and wastewater systems, the utility will charge the actual cost of the line extension or the additional facilities will be constructed by the property owner and donated to the utility consistent with the utility's existing service availability policy. The approved main extension and plant capacity charges are based on an equivalent residential connection (ERC); for connections greater than one ERC, the charge will be based on the estimated demand the new customer will place on the system.
