Commissioner Mariano,

Thank you for your inquiry into the purchase and sale of Corix and whether the transaction is or should be approved by the FPSC. The Office of Commissioner Brown has asked me to respond to your inquiry.

Our technical and legal staff have evaluated your e-mail and we've concluded that the Florida Public Service Commission (FPSC) has no jurisdiction over the sale of Corix or this transaction. Therefore, we have no jurisdiction to approve or disapprove the transaction. As I understand the situation, Corix is the parent company of Utilities Inc., and Utilities Inc. of Florida, a Florida based corporation, is one of UIF's operating companies. However, that scenario does not in itself give rise to FPSC jurisdiction over a parent company or separate transactions caused by or otherwise affecting a parent company. For fullness of my response, it is possible that any sale of a parent company could affect management and parent/subsidiary allocations, and in turn could possibly have some effect on a future rate case proceeding, but such a scenario is speculative and in any event still does not give rise to FPSC jurisdiction over a parent company or separate parent company transactions.

Further, we have reviewed and also agree with OPC's response provided to you by e-mail on November 8, 2017, which has been placed in the un-docketed docket file. This response will also be placed in our un-docketed docket file. Please let us know if we can be of further assistance.
