By this letter, Commission staff requests that The Harbor (The Harbor or utility) provide responses to the following data requests:

- 1. The utility's application indicates that the customers on Opal Drive receive water service from The Harbor, but not wastewater service. Please explain how the mobile homes and RVs on Opal Drive receive wastewater service.
- 2. The utility's application indicates that customers outside the resort are charged more for water service than customers within the resort. Please explain why the utility charges different rates for areas outside the resort and how those rates were developed.
- 3. In the utility's proposed tariff sheets, the utility did not provide an application for service or a sample customer bill. Please provide the application and a sample customer bill.
- 4. In the utility's proposed water tariff, it states that customers who own washers are charged an additional \$15 for water service. Please explain why customers are charged more if they own a washer. Are there any other supplementary charges that might apply to customers?
  - a) How does the utility identify whether a customer has a washer?
  - b) How does the utility identify whether a washer is added or removed from an existing customer location?
