Lakeside Waterworks, Inc.'s (Lakeside) submits its request for revisions in the approved Miscellaneous Service Charges. Lakeside previously requested these revisions in Docket No. 20160195-WS, the Staff Assisted Rate Case. See Document No. 01529-2017. However, this request was inadvertently not addressed in staff's recommendation.

Miscellaneous Service Charges

Lakeside does not believe the currently approved miscellaneous service charges recover all the costs associated with processing and administering each applicable charge. Lakeside is requesting revisions to its miscellaneous service charges consistent with recently approved charges for LP Waterworks, Inc. in Order No. PSC-2017-0334-PAA-WS, issued August 23, 2017. The costs are consistent with this related company. The appropriate cost justification pursuant to Section 367.091(6), Florida Statutes is attached. Lakeside respectfully requests the following charges be approved.
