**MOTION FOR ORDER AUTHORIZING CHAPTER 7 TRUSTEE TO  
MAKE INTERIM DISTRIBUTION TO CREDITORS AND FOR RELATED RELIEF**

Gus A. Paloian, not individually, but solely as the Chapter 7 Trustee (“Trustee”) of the above-referenced bankruptcy estate (“Estate”), hereby moves the Court pursuant to 11 U.S.C. §§ 105 and 726 for entry of an order authorizing him to make an interim distribution to creditors of the Estate and for related relief. In support of this motion, the Trustee states as follows:

**BACKGROUND**

1. On November 6, 2002 (the “Petition Date”), the Debtor filed its voluntary petition for relief under Chapter 11 of the Bankruptcy Code. On December 13, 2005, an Order was entered converting Debtor’s Chapter 11 Case to one under Chapter 7.
2. On December 13, 2005, Gus A. Paloian was appointed as Trustee of the Debtor’s Estate, and is duly-qualified and acting as such.

**Settlement of Certain of Estate Claims**

3. On October 27, 2007, the Court entered an order authorizing the Estate to compromise a claim in adversary proceeding 06-01190 against Russ A. Intravartolo (“Intravartolo”), a former executive of the Debtor. Doc. No. 917. Pursuant to the terms of the compromise, a judgment in the amount of \$381,696.13 was entered against Intravartolo. Doc.

No. 55-1. Also pursuant to the compromise, upon payment by Intravartolo of \$30,000.00 to the Estate within 90 days of the entry of the judgment, the balance of the judgment would be reduced to \$220,000.00. Intravartolo failed to make any voluntary payments during the 90 days after the entry of the stipulated judgment (or at any point thereafter).

4. Thereafter the Estate sought to collect the stipulated judgment through regular and repeated garnishments of Intravartolo's wages from his various employers. The Estate has recovered \$171,480.04 through garnishments since the entry of the stipulated judgment.

5. Despite repeated efforts to settle the balance due under the stipulated judgment, Intravartolo has refused to or cannot provide a lump sum settlement. Additionally, the Estate has sought to sell the judgment, but potential buyers have declined to purchase the judgment due to periods of unemployment. As such, the Estate is likely to remain open for an extended period of time to collect the balance of the stipulated judgment.

6. For this reason, the Estate seeks authorization to make an interim distribution to holders of allowed claims.

7. As of the date of presentation of this motion, the Estate possesses in excess of \$335,000.00 in Estate assets.

#### **Claims of Creditors Against The Estate**

8. Three Hundred and Eight (308) claims have been timely filed against the Estate totaling in excess of \$41,921,704.10 as filed. A substantial number of these claims were filed as general unsecured claims.

9. Through either objections or negotiations, the Debtor and later the Estate reached agreements with numerous holders of secured and priority claims either (1) to reclassify these secured claims as unsecured claims, or (2) to reduce such claims.

**RELIEF REQUESTED**

10. By this motion, the Trustee requests authority to make an interim distribution of up to \$150,000.00 to creditors, which will be distributed based upon secured or priority status then to unsecured claims on a pro rata basis as reflected in **Exhibit A**:

11. The proposed distribution of up to \$150,000.00 to creditors will leave the Estate with a cash reserve in excess of \$185,000.00 (the "Reserve"). The Trustee anticipates making additional recoveries from Intravartolo through continuing garnishments or from a possible future sale of the judgment. The Trustee believes that the Reserve is sufficient to cover all costs of administration of the Estate, including tax preparation and tax liability, if any, of the Estate. Further, the Trustee believes that the Reserve will provide sufficient assets to administer fully the Estate through its conclusion.

12. In order to protect the interests of the Estate in the interim distribution, the Trustee requests that the Court approve the Trustee's conditioning of the payment of an interim distribution to a creditor upon the creditor's agreement to refund the interim distribution to the Estate should the Trustee later determine, in his sole discretion, that such interim distribution should be returned to the Estate.

13. Because there is no reason to delay a distribution of assets at this time, the Trustee respectfully contends that a partial distribution is appropriate and in the best interest of the creditors of the Estate. Many creditors of the Estate have held claims against the Debtor for many years prior to the filing of the voluntary petition.

WHEREFORE, the Trustee respectfully requests that the Court enter an order (i) authorizing him to make an interim distribution of \$150,000.00 to the creditors of the Estate as set forth herein, (ii) authorizing the related relief on refunding, and (iii) granting such further relief as the Court deems appropriate.
