On July 28, 2017, Pluris Wedgefield, Inc. (Pluris) filed an application with the Florida Public Service Commission (PSC or Commission) for a limited proceeding water and wastewater rate increase. Pluris provides water service to approximately 1,600 customers and wastewater service to approximately 1,570 customers in Orange County.

QUESTIONS & ANSWERS

1 Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process for Pluris' rate request, the Commission staff will conduct a customer meeting to allow feedback about Pluris and the rate-setting process. Customer comments, written and oral, will be taken into consideration when the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

2 Why is Pluris requesting a rate increase?

Pluris is requesting this limited proceeding rate increase in order to recover specific costs incurred by the utility.

3 When was Pluris' last approved rate increase?

Pluris' last approved rate increase was in May 2013.

4 How much is the current monthly water and wastewater bill for a residential customer using 3,000 gallons?

The current monthly water and wastewater bill for a residential customer is \$48.08 and \$41.73, respectively.

5 Using Pluris' requested rates, how much would the monthly water and wastewater bill be for a residential customer using 3,000 gallons?

Using Pluris' requested rates, the monthly water and wastewater bill for a residential customer would be \$55.11 and \$44.38, respectively.
