EXTENSION OF INTERVENOR TESTIMONY FILING DATES**

Seminole Electric Cooperative, Inc., and Shady Hills Energy Center, LLC (collectively, "Petitioners"), by and through its undersigned attorneys and pursuant to Rule 28-2106.204, F.A.C., hereby respond to Quantum Pasco Power, L.P.'s, Michael Tulk's and Patrick Daly's Joint Motion for Extension of Intervenor Filing Dates Established by Order No. PSC-2018-0118-PCO-EC:

Petitioners do not object to a reasonable extension of the intervenor testimony filing date of up to seven days, provided that the same extension is granted for the filing dates for Staff and rebuttal testimony. However, Petitioners oppose the proposed eleven day extension insofar as it would unduly constrict the already limited time period between the filing of rebuttal testimony and the dates of the prehearing conference and final hearing.
