Hey Wes,

Thank you for the clarification. We will add Gunster/Keating as a party of record, and will not add Chesapeake. There is no need to add Mike as a contact for FPUC because as a part of “all electric utilities,” that information is pulled from MCD and Mike is the contact person shown in MCD for FPUC. If we add FPUC/Cassel separately, the system will recognize the information as duplicative.
