Thank you for contacting the Office of Commission Clerk regarding the removal of contact information from our system. Docket No. 20170261-TC is currently open to address the cancellation of PATS Certificate No. 8870 (Cert No. 8870) by Central Florida Haven of Hope Ministries, Inc., effective 12/31/17. According to the events in that docket, an administrative order is due to be filed on 2/20/18. Until that order is issued, Cert No. 8870 is still considered "active" in our Master Commission Directory, and we are unable to remove your information from that notification list. There are two rule dockets (20170262-TP and 20170263-TP) which are going to the 2/6/18, agenda. Those two dockets affect all telecommunications companies, and that is why you received notification of the Agenda. After the order mentioned earlier is issued and Cert No. 8870 has been cancelled, your information will be removed and you will receive no further notifications related to things which affect all telecommunications companies.
