Chairman Graham and Staff,

I'm reaching out on behalf of Sunrun Inc. as we have a Petition for Declaratory Statement pending before the Commission. As you may recall, our item was discussed during the March Agenda Conference and we decided to waive the Commission's statutory deadline in order to

allow the Commissioners to defer their vote until they and their staff were able to review our Florida lease. We filed our lease in the docket on Monday, March 20 and are hoping for a spot on the April Agenda Conference for further discussion.

We would greatly appreciate your time to briefly discuss our supplemental filing and proactively address any questions you may have about this document and our petition. We understand this is a new question in Florida and we want to do everything we can to be transparent and forthcoming, as well as responsive to any concerns or questions. If you are unavailable, we would still greatly value time with your staff for the same discussion.

I would welcome the opportunity to meet anytime between now and the Agenda Conference, with the exception of April 10-11, as I've committed to support a FERC technical conference during those days. Should you or your staff be available on Friday, April 6, I would also arrange for our Chief Policy Officer to join us. Anne Hoskins was a Maryland PSC Commissioner before she joined Sunrun and may be uniquely able to address questions from your vantage point.

Out of respect of your position, please know that we have researched the Commission's ex parte rules and we are confident that such a meeting is not subject to ex parte limitations, as Petitions for Declaratory Statement are exempt from Rule 25-22.033.
