Per the Statute, propriety of confidential business information includes, but is not limited to; Subsection (d) "[i]nformation concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms," and Subsection (e) "[i]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information."

The information provided in response to Staff's 1<sup>st</sup> Data Request, No. 26, for which confidential treatment is being sought can be described as fuel commodity price forecasts which the Company obtained from third-party providers, namely PIRA and Wood MacKenzie.

It is staff's opinion that the information that is the subject of this request meets the criteria for confidentiality contained in Section 366.093(3)(d), F.S., and Section 366.093(3)(e), F.S.
