To Whom It May Concern:


Strome Networks, LLC ("Strome") files an original and one copy of this request to withdraw its CLEC certification previously granted in Florida Docket No. 20170108-TX.

Despite its earlier plans to do so, Strome has never provided intrastate telecommunications services in Florida and has made a business decision not to provide such services in the future. Strome has never served any intrastate telecommunications customers and received no revenues associated with its certificate. *See, e.g.,* attached Fee Return for 2017.
