- 1. Referring to the response to number three of staff's first data request, please clarify the second sentence and explain if TECO will ever disconnect without notice pursuant to proposed subsection (12).
- As indicated in Tampa Electric's response to question 3 in Staff's first data request, the company expects that service to the customer will have already been disconnected for cause at the point where the company is faced with the decision to implement the tariff authority being sought in its petition. However, in accordance with Rule 25-6.105(5) Tampa Electric may not provide 5 days written disconnection notice in the event of a known hazardous condition, in the event of tampering with meters or other utility equipment, or unauthorized or fraudulent use of service. If faced with a situation where the company is having to disconnect service specifically because of a threatening condition, the company will issue the customer a 5-day disconnect notice.
