On October 15, 2018, Florida City Gas filed revised tariff pages and rate changes to reflect a Stipulation and Settlement regarding remaining Excess Accumulated Deferred Income Tax issues reached by Florida City Gas, the Office of Public Counsel, and the Federal Executive Agencies. It has been found that the Distribution Charge per Lamp on Sheet No. 46 was not updated as part of this filing to \$10.66 from \$10.72 to reflect the reduction in the Distribution Charge Per Therm properly updated on Sheet No. 46. This correction has no impact on customers' bills as the billing has yet to commence.
