# FLORIDA POWER & LIGHT COMPANY'S FIRST REQUEST FOR EXTENSION OF CONFIDENTIAL CLASSIFICATION OF <u>AUDIT CONTROL NO. 16-005-4-1 WORK PAPERS</u>

Pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Florida Power & Light Company ("FPL") requests continued confidential classification of certain information provided to the Staff of the Florida Public Scrvice Commission ("Staff") pursuant to Audit Control Number 16-005-4-1 ("the Audit") and reflected in Staff's work papers. In support of its request, FPL states:

1. On July 1, 2016 FPL filed a Request for Confidential Classification of portions of the Audit work papers. FPL's request was granted by Order No. PSC-2017-0305-CFO-EI, dated August 2, 2017.

2. The period of confidential treatment granted in Order No. PSC-2017-0305-CFO-EI will soon expire. FPL has reviewed the confidential documents and determined that all the information that was subject of Order No. PSC-2017-0305-CFO-EI warrants continued treatment as proprietary and confidential business information within the meaning of Section 366.093(3), Florida Statutes.

3. FPL hereby submits its First Request for Extension of Confidential Classification. Exhibits A and B from FPL's July 1, 2016 filing are incorporated herein by reference. Included herewith are First Revised Exhibit C and First Revised Exhibit D.

4. First Revised Exhibit D contains the declarations of Antonio Maceo and Lisa Fuca in support of this request. Regarding First Revised Exhibit C, all of the information listed in the July 1, 2016 Request remains confidential; the exhibit is revised only to identify Lisa Fuca as a new declarant.

5. The information that was granted confidential treatment by Order No. PSC-2017-0305-CFO-EI continues to be confidential business information within the meaning of Section 366.093(3), Florida Statutes. This information is intended to be and is treated by FPL as private in that the disclosure of the information would cause harm to customers or FPL's business operations, and its confidentiality has been maintained. Pursuant to Section 366.093, such information is entitled to confidential treatment and it is exempt from the disclosure provisions of the public records law. Thus, once the Commission determines that the information in question is proprietary confidential business information, the Commission is not required to engage in any further analysis or review such as weighing the harm of disclosure against the public interest in access to the information.

6. As the declarations in Second Revised Exhibit D indicate, some of information in the Audit work papers is proprietary, confidential business information. The Audit work papers contain information related to reports of internal auditors. This information is protected from public disclosure by Section 366.093(3)(b), Florida Statutes. The work papers also contain information related to bids or contractual data, such as pricing and other contractual terms, the public disclosure of which would violate nondisclosure provisions of FPL's contracts with certain vendors and impair FPL's ability to contract for goods or services on favorable terms in the future. Such information is protected from public disclosure by Section 366.093(3)(d), Florida Statutes. The work papers also include competitively sensitive information which, if

disclosed, could impair the competitive interests of the provider of the information. Such information is protected from public disclosure by Section 366.093(3)(e), Florida Statutes. Additionally, a few documents include competitively sensitive information related to certain employees' compensation. Public disclosure of compensation information would enable competing employers to meet or beat the compensation currently offered, resulting in the loss of talented employees, or conversely, the need to increase the level of compensation already paid in order to retain these employees and attract new talent. The quality of service and the cost of service implications would be detrimental to FPL and its customers. Such information is also protected by Section 366.093(3)(e), Florida Statutes.

7. Nothing has changed since the issuance of Order No. PSC-2017-0305-CFO-EI to render the confidential information stale or public, such that continued confidential treatment would not be appropriate.

8. Upon a finding by the Commission that the information continues to be proprietary confidential business information, the information should not be declassified for a period of at least an additional 18 months and should be returned to FPL as soon as the information is no longer necessary for the Commission to conduct its business. *See* § 366.093(4), Fla. Stat.

WHEREFORE, for the above and foregoing reasons, as supported by the materials and declarations included herewith, Florida Power & Light Company respectfully requests that its First Request for Extension of Confidential Classification be granted.
