Network Billing Systems, L.L.C. dba Fusion dba Solex (“Company”) hereby notifies the Florida Public Service Commission (“Commission”) that effective April 1, 2019, the Company is changing its name to **Fusion Connect LLC** (“Fusion”). A copy of Fusion’s Florida Department of State name registration is attached.
