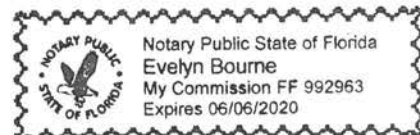

By Order No. PSC-2019-0047-PAA-WS, in Docket No. 20170249-WS, issued January 25, 2019, the Florida Public Service Commission (Commission) approved allocated water and wastewater rates, miscellaneous service charges, a late payment charge, Non-Sufficient Funds (NSF) charges, and customer deposits for RSPI MHC, LLC (RSPI or utility). A schedule of Commission approved rates, charges, and customer deposits are set forth below.

- Or by five (5) percent of the face amount of the check, whichever is greater
