Walmart Inc. ("Walmart") requests that it be excused from attending the Prehearing Conference and Hearings in the above-referenced consolidated cases in which you serve as the Prehearing Officer. The Prehearing Conference and Hearings are currently scheduled for July 29, 2019, and August 12-16, 2019, respectively.

Subsequent to intervening and after the review of submissions by the utilities, discovery, and filings by other parties, Walmart determined that it would not submit testimony or advance a substantive position. Accordingly, in its Prehearing Statement, Walmart has taken "no position" on the issues in these proceedings. As such, Walmart would like to avoid the expense associated with traveling and attending the Prehearing Conference and Hearings.
