

**FLORIDA POWER & LIGHT COMPANY'S REQUEST
FOR CONFIDENTIAL CLASSIFICATION OF INFORMATION PROVIDED
IN RESPONSE TO VOTE SOLAR'S FIRST SET OF INTERROGATORIES (No. 58)**

Pursuant to Section 366.093, Florida Statutes ("Section 366.093"), and Rule 25-22.006, Florida Administrative Code, Florida Power & Light Company ("FPL") hereby requests confidential classification of certain information provided in response to Vote Solar's First Set of Interrogatories, No. 58 (collectively, the "Confidential Documents"). In support of this Request, FPL states as follows:

1. FPL served its responses to Vote Solar's First Set of Interrogatories, Nos. 1-64 on September 3, 2019. This Request is being filed contemporaneously with service of those responses in order to request confidential classification of certain information contained in its response to Interrogatory No. 58, consistent with Rule 25-22.006, Florida Administrative Code.
2. The following exhibits are attached to and made a part of this Request:
 - a. Exhibit A consists of a copy of the Confidential Documents on which all information that FPL asserts is entitled to confidential treatment is highlighted.
 - b. Exhibit B consists of an edited version of the Confidential Documents on which all information that FPL asserts is entitled to confidential treatment is redacted.
 - c. Exhibit C is a table that identifies the information highlighted in Exhibit A and references the specific statutory basis for the claim of confidentiality and identifies the Declarant who supports the requested classification.

- d. Exhibit D consists of the declaration of Jennifer Schaffer in support of this Request.
3. FPL submits that the highlighted information in Exhibit A are documents or materials that I have reviewed and which are asserted by FPL to be proprietary confidential business information contain or constitute customer-specific information. It is FPL's corporate policy not to disclose customer-specific information. This policy includes, but is not limited to: customer names, addresses, telephone numbers, account numbers, rates, billing determinants (kW and kWh usage), conservation savings in kW, kWh and bills. FPL treats such information as confidential and does not disclose it, except as required by law, to entities or persons other than the customer absent the customer's consent.
 4. As described in the declaration in Exhibit D, some of the confidential business information contain or constitute customer-specific information, the disclosure of which would impair the competitive business of the provider of the information. This information is protected by Section 366.093(3)(e), Fla. Stat.
 5. Upon a finding by the Commission that the information contained in the Confidential Documents is proprietary and confidential business information, the information should not be declassified for at least eighteen (18) month period and should be returned to FPL as soon as it is no longer necessary for the Commission to conduct its business. *See* § 366.093(4), Fla. Stat.

WHEREFORE, for the above and foregoing reasons, as more fully set forth in the supporting materials, Florida Power & Light Company respectfully requests that its Request for Confidential Classification be granted.


