The purpose of this prehearing conference is to: (1) simplify the issues; (2) identify the positions of the parties on the issues; (3) consider the possibility of obtaining admissions of fact and of documents which will avoid unnecessary proof; (4) identify exhibits; (5) establish an order of witnesses; and (6) consider such other matters as may aid in the disposition of the action.

PURPOSE AND PROCEDURE:

The purpose of this hearing is the evaluation of Tampa Electric Company's 2017 Amended and Restated Stipulation and Settlement Agreement that included a Solar Base Rate Adjustment mechanism which provides for the recovery of costs associated with solar projects that meet the criteria laid out in that 2017 Settlement Agreement. The Commission will conduct a Limited Proceeding to approve the third Solar Base Rate Adjustment and to take action on any motions or other matters that may be pending at the time of the hearing and any motions or other matters that may be pending at the time of the hearing. The Commission may rule on any such motions from the bench or may take the matters under advisement.

At the hearing, all parties shall be given the opportunity to present testimony and other evidence on the issues identified by the parties at the prehearing conference held on October 8, 2019. All witnesses shall be subject to cross-examination at the conclusion of their testimony.
