The following is South Sumter Utility Company, L.L.C.'s response to Staff's November 8, 2019 letter addressing the proposed Notice.

1. Rule 25-30.030(3)(f), Florida Administrative Code, (F.A.C.), requires that the notice should be titled "Notice of Application for Authority to Transfer Assets of an Exempt Entity to a Regulated Utility." Please amend the notice to add the words "Notice of" to the beginning of the title.
RESPONSE: See attached revised Notice.
2. Rule 25-30.030(4)(b), F.A.C., requires that the notice contain the name, address, telephone number, and, if available, email address and fax number of the applicant. Please amend the notice to include the email address and fax number of the applicant. If not available, please state that it is not available.
RESPONSE: See attached revised Notice.
3. Rule 25-30.030(4)(d), F.A.C., requires that the notice include the application docket number and title. Please amend the notice to contain the docket number.

RESPONSE: See attached revised Notice.

4. Rule 25-30.030(4)(e), F.A.C., requires that the notice include the common reference of street names bordering the area served by the utility, if applicable. It is clear that County Road 468 borders the area being served to the north. Please amend the notice to provide the common local reference of this street name, and others if applicable.

RESPONSE; Since a portion of new service area is north of County Road 468 it is not completely accurate to say County Road 468 borders the new service area on the north, so I have used the term abutting County Road 468.

5. Rule 25-30.030(4)(g), F.A.C., requires that the notice include a statement that the utility is not requesting any changes to its rates, classifications, charges, rules, and regulations in the application. Please amend the notice to include this statement.
