**Re: Docket No. 20190182-WS - Application to transfer facilities and Certificate No. 578-W from Sunny Shores Water Co. to Sunny Shores Utilities, LLC, in Manatee County.**

Dear Mr. Smallridge:

Staff reviewed the draft notice provided by Sunny Shores Utilities, LLC. (Sunny Shores or Utility) on December 11, 2019. To obtain Commission approval of its notice, Sunny Shores should make the following changes to its notice:

1. Rule 25-30.030(3)(e), Florida Administrative Code, (F.A.C.), requires that the notice should be titled "Notice of Application for Authority to Transfer Water Certificate of Authorization to Another Regulated Utility." Please amend the notice to add this title.
2. Rule 25-30.030(4)(b), F.A.C., requires that the notice contain the name, address, telephone number, and, if available, email address, and fax number of the applicant. Please amend the notice to include the email address of the applicant.
3. Rule 25-30.030(4)(c), F.A.C., requires that the notice include the common name of developments served by the utility. Please amend the notice to include the common names of the developments served by the Utility.
4. Rule 25-30.030(4)(d), F.A.C., requires that the notice include the application docket number and title. Please amend the notice to contain the docket number and title as shown in the subject line of this letter.
5. Rule 25-30.030(4)(e), F.A.C., requires that the notice include the common reference of street names bordering the area served by the utility, if applicable. It appears that the service territory is bordered by 40 Avenue West and 115 Street West. Please amend the notice to include this information.

6. Rule 25-30.030(4)(g), F.A.C., requires that the notice include a statement that the utility is not requesting any changes to its rates, classifications, charges, rules, and regulations in the application. Please amend the notice to include this statement.

Please make the changes noted in items 1 through 6 above, as well as updating the date to reflect the present date, and submit the corrected notice to the Office of Commission Clerk, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, referencing Docket No. 20190182-WS, no later than **January 6, 2020**.
