ASSIGNMENT, ASSUMPTION AND ADOPTION AGREEMENT OF INTERCONNECTION, COLLECTION AND RESALE AGREEMENT

- 1. This assignment, assumption and adoption agreement (this "Assignment") is made as of January 31, 2020 (the "Effective Date") in connection with the Interconnection, Collection and Resale Agreement for the State of Florida, dated March 20, 2007, by and between NuVox Communications, Inc. and Embarq Florida, Inc. d/b/a CenturyLink ("CenturyLink"), as adopted by Electronet Broadband Communications, Inc. ("Electronet") pursuant to the Interconnection, Collocation and Resale Agreement, dated December 1, 2011, by and between Electronet and CenturyLink, which was approved by the Florida Public Service Commission on March 22, 2012 (as amended, restated, supplemented or modified from time to time, the "Interconnection Agreement"). Electronet has entered into the Asset Purchase Agreement, dated as of November 27, 2019, between Electronet and Hargray of Florida, Inc. ("Hargray"), pursuant to which Hargray has agreed to acquire substantially all of the assets of Electronet, including the Interconnection Agreement.
- 2. CenturyLink hereby approves the assignment by Electronet of the Interconnection Agreement to Hargray, such assignment to be effective as of the Effective Date. Pursuant to Section 17.2 of the Interconnection Agreement, CenturyLink hereby confirms that the Interconnection Agreement (including the facilities and services being provided to Electronet thereunder) will remain in full force and effect, and without interruption, in accordance with its terms following the consummation of the Assignment, and agrees that the consummation of the Interconnection Assignment does not constitute a violation or default of the Interconnection Agreement.
- 3. Hargray hereby agrees to assume the obligations and duties of Electronet under the Interconnection Agreement, such assumption to be effective as of the Effective Date.
