We went out and reviewed the road and discovered there were no further issues. It had not changed since last time it was reviewed. Merritt Island is aware that on this street - along with another one or two - the old wastewater collection mains will need to be replaced. These are located under the road. It is estimated the cost would be around \$300,000 or more.
