

On April 1, 2019, Aquarina Utilities, Inc. (Aquarina) filed an applice on with the Florida Public Service Commission (PSC or Commission) for a limited proceeding to crease. Aquarina provides water and wastewater service to approximately 31 water 120 con-potable, and 340 wastewater customers in Brevard County.

### QUESTIONS & ANSWERS

## 1 Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation procession Aquarina's rate request, the Commission staff will conduct a customer meeting to allow feedback about Aquarina and the rate patting cess. The utility's current monthly water and wastewater bill for a residential customer using 2,000 gallons is \$34.16 and \$35.45, respectively.

Using the Utility's proposed rates, the monthly water and wastewater bill for a residential customer using 2,000 gallons would be \$51.71 and \$35.45, respectively.
