

FAR NOTICE OF HEARING

PUBLIC SERVICE COMMISSION

The FLORIDA PUBLIC SERVICE COMMISSION announces a hearing in the following docket to which all persons are invited.

DOCKET NOS. AND TITLES: 20200145-EI - Petition to approve the 2020 settlement agreement by Tampa Electric Company; 20200064-EI – Petition for a limited proceeding to approve fourth SoBRA, by Tampa Electric Company; 20200065-EI – Petition for a limited proceeding to eliminate accumulated amortization reserve surplus for intangible software assets, by Tampa Electric Company; 20200067-EI – Review of 2020-2029 Storm Protection Plan pursuant to Rule 25-6.030, F.A.C., Tampa Electric Company; 20200092-EI – Storm protection plan cost recovery clause.

HEARING DATE AND TIME: Tuesday, June 9, 2020, starting immediately after the Commission’s Agenda Conference scheduled to commence at 9:30 a.m. on that date.

PLACE: Room 148, Betty Easley Conference Center, 4075 Esplanade Way, Tallahassee, Florida.

GENERAL SUBJECT MATTER TO BE CONSIDERED AT THE HEARING:

The purpose of this hearing shall be to consider Tampa Electric Company’s Petition to approve its 2020 Agreement, and to take action on any motions or other matters that may be pending at the time of the hearing. The Commission may rule on any such motions from the bench or may take the matters under advisement. This proceeding shall: (1) allow the parties to present evidence and testimony in support of their positions; and (2) allow for such other purposes as the Commission may deem appropriate.

PUBLIC TESTIMONY: Because the Commission is operating under a state of emergency due to COVID-19, any member of the public who wishes to offer testimony must do so remotely by telephone or by written comment. Any written comments must be filed in the docket file no later than 12:00 p.m. on June 4, 2020. To participate telephonically, members of the public must contact the Office of General Counsel at (850) 413-6199 by noon on June 4, 2020. By providing public testimony, a person does not become a party to the proceeding. To become an official party of record, you must file a Petition for Intervention at least twenty days before the final hearing, pursuant to the requirements contained in Rule 28-106.205, Florida Administrative Code (F.A.C.).

All witnesses shall be subject to cross-examination at the conclusion of their testimony. The hearing will be governed by the provisions of Chapter 120, Florida Statutes, Chapter 366, Florida Statutes, and Chapters 25-22 and 28-106, Florida Administrative Code.

SPECIAL COVID-19 CONSIDERATIONS

As the Governor of the State of Florida and Leon County have declared a state of emergency due to the COVID-19 Pandemic, the Commission must limit the manner in which the public may participate or view the Hearing. Due to these extraordinary circumstances, however, no member of the public may attend in person.
