Florida Power & Light Company ("FPL") hereby requests to withdraw its Notice of Intent to Request Confidential Classification (DN 02756-2020) filed on May 26, 2020.

Based upon communications with the Office of Public Counsel ("OPC"), FPL filed its Notice of Intent to Request Confidential Classification in anticipation that information contained in the direct testimony and exhibits of OPC's witness Kevin J. Mara would include confidential information protected from public disclosure by Florida law. However, upon receipt and review of the testimony of OPC witness Mara, FPL has determined that Mr. Mara's testimony is not confidential and, therefore, the Notice of Intent to Request Confidential Classification filed On May 26, 2020, is not necessary.
