Good afternoon Mr. Andrews. Attached is the additional information you requested in follow up to documents the Utility produced in response to the OPC's First Request for Production of Documents ("PODs").

- 1. With respect to PODs 11 and 15, the lease payment was based on fair market property values derived from a survey of recent lot sales in the Bell Villa subdivision. Attached are the lots found, with pertinent details included.
- 2. With respect PODs 9,10, 13,14, and 17, the flowmeter calibration charge of \$1,330 recorded in Account 631- Contract Engineering Costs is an annual charge. As shown in the attached, a \$1330 calibration charge was actually incurred in June of 2018. A similar charge of \$1,989 for calibration was incurred in April 2017.
- 3. Also attached are relevant Lee County property tax bills reflecting the millage rate used.
