This letter is to request that the Florida Public Service Commission ("Commission") submit a letter to the Federal Communications Commission ("FCC") and the Universal Service Administrative Company ("USAC") certifying that ATT Florida is in compliance with all provisions of Section 254(e) of the Telecommunications Act.

The amount of federal high-cost support AT&T Florida will receive in 2021 will be used for the services and functionalities outlined in 47 C.F.R. §54.101(a) and, as the attached affidavit shows, AT&T Florida certifies that it will only use the federal high cost support it receives for the provision, maintenance, and upgrading of facilities and services for which such support is intended.
