## NOTICE OF PROPOSED AGENCY ACTION ORDER APPROVING TRANSFER OF CERTIFICATE OF AUTHORITY NO. 4405

## BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission (Commission) that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

On January 10, 2020, Virtual Offices, Inc. d/b/a The Centers of Westshore (Virtual Offices) filed with this Commission an application for approval of transfer of Certificate No. 4405 from Accent Property Management, LLC d/b/a The Centers of Westshore. Upon review of the application, it appears that Virtual Offices has sufficient technical, financial, and managerial capability to provide such service. Accordingly, we hereby approve the transfer of Certificate of Authority No. 4405<sup>1</sup> to Virtual Offices and thereby authorize Virtual Offices to provide telecommunications service.

Telecommunications service providers are required to comply with all applicable provisions of Chapter 364, F.S., and Chapter 25-4, F.A.C.

In addition, under Section 364.336, F.S., certificate holders must pay a minimum annual Regulatory Assessment Fee (RAF) if the certificate was active during any portion of the calendar year. A RAF Return notice will be mailed each December to Virtual Offices for payment by

January 30th. Neither the cancellation of its certificate nor the failure to receive a RAF Return notice shall relieve Virtual Offices from its obligation to pay its RAF.

If this Order becomes final and effective, it will serve as Virtual Offices' certificate. Virtual Offices shall retain this Order as proof of its certification. We are vested with jurisdiction over this matter pursuant to Sections 364.335 and 364.336, F.S.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Virtual Offices, Inc. d/b/a The Centers of Westshore's Application for transfer of Certificate No. 4405 is hereby granted. It is further

ORDERED that Virtual Offices, Inc. d/b/a The Centers of Westshore is authorized to provide telecommunications service, subject to the terms and conditions set forth in the body of this Order. It is further

ORDERED that this Order shall serve as Virtual Offices, Inc. d/b/a The Centers of Westshore's certificate and shall be retained by Virtual Offices, Inc. d/b/a The Centers of Westshore as proof of certification. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Commission Clerk, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings" attached hereto. It is further

ORDERED that in the event this Order becomes final, this docket shall be closed.
